County employees and volunteers work with community partners and private sponsors to purchase, wrap and deliver gifts to recipients during November and December of every year:

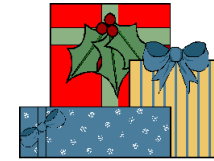
- ◇ Social workers request gifts for children, youth, and senior clients on their caseloads.

- ◇ Partners and sponsors purchase and wrap gifts for clients they selected.

- ◇ Social workers deliver gifts to the recipients in time for the holidays.

Founded in 1988, the Gifts From The Heart Program is an annual holiday gift-giving program that provides gifts to children, teens, seniors and dependent adults served within county programs including: Child Protective Services, Senior & Adult Services Divisions, and the Public Guardian/Conservator office in the Department of Health & Human Services (DHHS).

Each season, more than 90 community organizations and private sponsors donate 10,000 gifts to thousands of vulnerable and isolated clients who would otherwise be without holiday gifts.

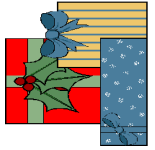
